The snehankur adoption center and initiative of snehalaya. Was launched in 2004 snehankur is a professionally managed licensed adoption center. The snehankur project is managed by a qualified team of social worker (specially MSW) Child care specialist, Consulting peditricians, legal advisers, family counselor and co- coordinator.

Snehankur was expanded and setup and setup as separate facilities for child care and adoption in Ahamednagar, taunt Maharashtra in India. Since the last 10 years hundreds of children's have been rescued rehabilitation and placed in good home by snehankur. Dr. Girish kulkarni Sir said “ Every child must have a family and an opportunity to find its potential every mother who is unable to bring up the child should be rehabilitated into the society with dignity.

Objective of snehankur organization

- 1) To provide excellent care, medical help and affection for abandoned And Relinquished children in the society.

- 2) To Find Suitable families for adoption and place orphan in good homes providing them a bright future.
  - 3) To provide information, Guidance, Counseling for families and co-ordinate the Process of adoption.
  - 4) To rehabilitated unwed mother by providing shelter legal help emotional support training for vocational skill and facilitating social reintegration.
- Snehankur has place hundreds of boys and girls in good families through adoption.

Mr.Balu Warule is a coordinator to snehankur. There is one counselor, she name is kanchan umap. She is handling the all perspective adoptive parents. Then there is a one accountant, she's name is Shubhangi Kalewagh. And she is take a responsibility to all bills and all transaction in snehankur. and pallavi madam and shilpa madam handle the PRO Section. There is a 4 sister, they are check the baby's health every day and treat it with the right medicine. Also there is 35 care taker ,they care to every child and as well as 3 driver.

## **Adoption Process:-**

Social trainer student gone to snehalaya, snehankur, kedgav organization. First of all Social trainer student understood the background of snehankur as well as rule and regulation then meet to All administrative staff. Social trainer student was understood the what is the adoption process and which document are important to successfully adoption process. And also understood the what is the CARA web site and also important of CARA Web site for Adoption process.

The procedure for adoption of a child in snehankur( CARA web site) can be understood in the following step.

Step 1 Registration in CARA Web site

Step 2 Home study and counseling

Step 3 Referral of the child (child medical history included)

Step 4 Acceptance of the child (in particular agency)

Step 5 Filling of Petition

Step 6 Pre adoption foster cares

Step 7 court hearing

Step 8 court order

The above method is important for successful completion of the adoption process.

### **Abandonment process:-**

Abandonment process in CWC office (Child Welfare committee )

in case the biological parent or unwed (single mothers) mothers doesn't want to undertake the legal process of surrendering the child and is unwilling to apply as per form 23 of the child and the cwc should following the procedure as in case of abandoned child.

- 1) That she/he/they have 60days for reconsideration of their decision.
- 2) That the child can be declared legally free for adoption by cwc if the child is not claimed within 60 day.
- 3) That the child may go in adoption to another family after being declared legally free for adoption by CWC.
- 4) That they will have no claim / legal right over the child after the child is declared legally free for adoption by cwc and or after the adoption order is issued by the competent court.

### **Home study report process regarding Adoption:-**

Social trainer student learned in this month how to prepare home study report process regarding perspective adoptive parents. Social trainer student understood the more thinking about home study report.

Home study report are often used to introduce your family's to other agency or adoption exchanges (services that list children who are hoping for adoptive families. )to assist them in matching your family with a child who is waiting for adoption.

In addition to health and income statements, background checks, and references has study report also include the following types of information for each prospective adoptive parent.

- 1) Family background
- 2) Relationship (Husband and wife)
- 3) Education / Employment (salary and other income)
- 4) Daily life rutting
- 5) Parenting (information about experience with child)

- 6) Neighborhood (community Resources)
- 7) Religion (information about parent's religion)
- 8) Feeling about (for Adoption)
- 9) Support system (Family support and Family acceptance)
- 10) Approval/ Recommendation (summary of home study)

### **Case follow up and Bring a New Case)**

Social trainer student are learned about case follow up. Social trainer student visited to unity hospital regarding sonography to pregnant women and single mothers. As well as gone to the priti deshapande hospital regarding rutting checkup to the new case and pregnant women's in snehalaya. Social trainer student gone on 22/10/2021 in kharda village in jamkhed taluka about bring a new baby boy(1 day) case. Social trainer student aslo visited Tisgao village in Pathardi village on 27/10/2021. Regarding bring a new baby boy (18 month) case. Also social trainer student learned by court hearing process after adoption.

### **Adoption Ceremony:-**

After a home study has been accepted and approved. A suitable child admitted and legally free for adoption. Then snehankur employees start the adoption ceremony process. That means invited the main guest, setting management and making a 1 PPT regarding adoption ceremony. And last giving the child to perceptive adoptive parents. And then giving the best wishes and last distributed the sweet item. Then competed the adoption ceremony. After the ceremony agency will gives information to parents about the baby feeding, baby nutrition, baby care act. Social trainer student played the role of witness three times regarding baby adoption.

### **Overall impression about internship:-**

The social trainer student is a very much happy content. And thankful for getting such a wonderful experience in the internship. Snehankur adoption center is a wonderful concept of snehalaya. Children's who do not have child love their parents and who do not have child love their child its possible to only Snehankur agency.
